

TERMS AND CONDITIONS GOVERNING THE DBS COMMERCIAL CARDS AND ESSO FLEET CARD PROMOTION (“PROMOTION”):

Promotion Period: 1 April 2024 – 30 Apr 2025

Qualifying process:

1. Register for the DBS Commercial Cards and Esso Fleet Card Promotion through the ESSO registration page from 1 April 2024 onwards using referral code “**DBSESSO**”
 2. DBS Commercial Card must be selected as the preferred payment method.
- This Promotion is open to all cardholders of a DBS Commercial Card AND an Esso Fleet Card, except DBS Commercial cardholders with existing Esso Fleet Card accounts as at 1 April 2024.
 - “Eligible Card” means Cardmember’s card account(s) must not be suspended and in good standing (i.e. to abide by the Terms and Conditions listed in the DBS Card Agreement) with DBS throughout the Promotion. Cardmembers whose card account(s) fulfil the Qualifying Spend during the Promotional Period but, for any reason, is terminated/cancelled before or during the Promotion Period will not be able to receive the Reward(s).
 - “Qualifying Spend” means transactions for the purchase of fuel under the Esso Fleet Card in Singapore that are successfully charged on a recurring basis to a DBS Commercial Card for payment.
 - Only spend posted to the Eligible Card Account after registration will be considered as Qualifying Spend. DBS shall not be responsible for any failure or delay in posting of sales transactions which may result in Cardmembers being ineligible for the promotion.


